The following communication, dated 17 November 2021 and received on 18 November 2021, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(c) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia hereby notifies to extend the imposition of a safeguard measures in the form of ad valorem safeguard duty on the importation of Subject Goods, for a period of 3 years by the issuance of Minister of Finance's Decree Number 156/PMK.010/2021 dated 9 November 2021 can be found in the website of the Indonesian Safeguard Committee: <a href="https://www.kppi.kemendag.go.id">www.kppi.kemendag.go.id</a>, promulgated in the Official Gazette of the Republic of Indonesia Number 1236 and came into effect on 18 November 2021.

#### 1 GENERAL BACKGROUND

On 14 July 2021 the Republic of Indonesia notified the findings of investigation in which it was concluded that the relevant safeguard measures need to be extended, in particular to prevent serious injury suffered by the Applicants. The extension of such safeguard measures will also give the Applicants opportunity to continue their adjustment program in order to improve the competitiveness of domestic industry (G/SG/N/8/IDN/20/Suppl.1 - G/SG/N/10/IDN/20/Suppl.2).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia, to extend the imposition of a safeguard measures duty on the importation of the Subject Goods in the form of an ad valorem safeguard duty, both in terms of amount and duration of such measure.

### **2 DESCRIPTION OF THE SUBJECT GOODS**

The description of the subject goods are as follows:

"Ceramic flags and paving, hearth or wall tiles, under Harmonized System (HS.) Codes: 6907.21.91, 6907.21.92, 6907.21.93, 6907.21.94, 6907.22.91, 6907.22.92, 6907.22.93, 6907.22.94, 6907.23.91, 6907.23.92, 6907.23.93, 6907.23.94"

#### **3 DESCRIPTION OF THE PROPOSED MEASURE**

With reference to the proposal from the Investigating Authority, and taking into account the need to effectuate the safeguard measures as proposed and the relevant requirements stipulated in the WTO Agreement on Safeguards, the Government of the Republic of Indonesia has decided to impose the following safeguard duty:

#### **TIMETABLE OF THE SAFEGUARD DUTY**

Period	Safeguard Duty
First Year (18 November 2021 - 17 November 2022)	17%
Second Year (18 November 2022 - 17 November 2023)	15%
Third Year (18 November 2023 - 17 November 2024)	13%

Below is the list major exporting members of imports of the product involved and the list of developing countries excluded from the said safeguard measures, and the Government of the Republic of Indonesia reserves the right to modify this list in light of changing import volumes exceeded 3%.
